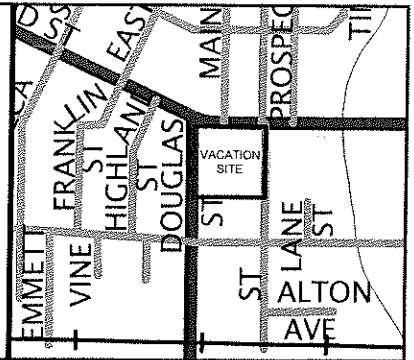


PLAT OF VACATION GREENLER'S ADDITION TO EAST DEFIANCE
