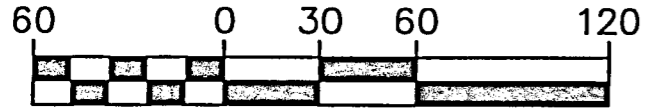


VACATION PLAT FOR A 13.2 FEET WIDE ALLEY IN TOWN  
 PLAT OF NORTH DEFIANCE, CITY OF DEFIANCE, OHIO

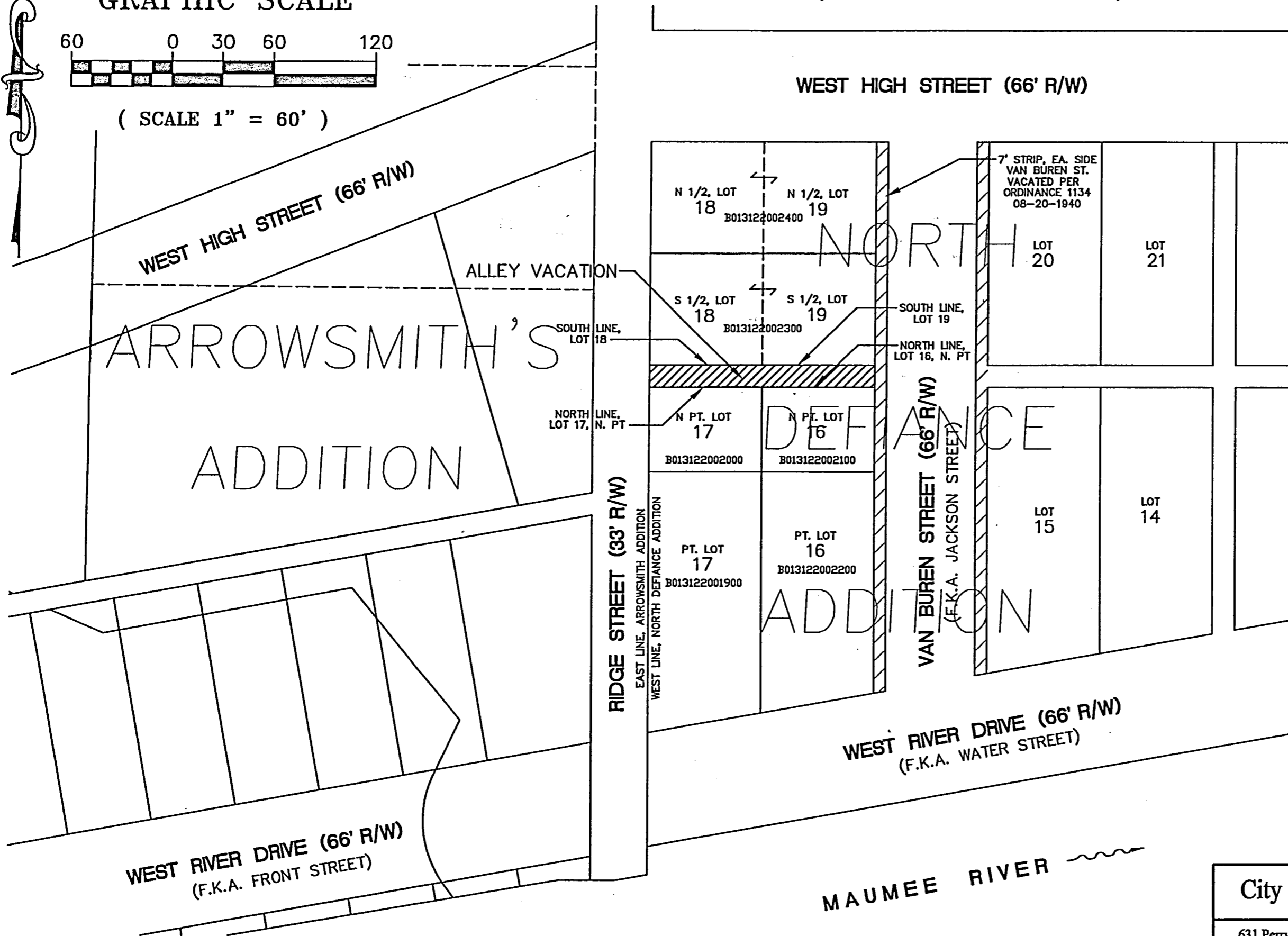
GRAPHIC SCALE

THE NORTH LINE OF SAID ALLEY ALSO BEING THE SOUTH PARCEL LINE OF LOT NOS. 18 & 19, AND THE SOUTH LINE OF SAID ALLEY ALSO BEING THE NORTH PARCEL LINE OF LOT NO. 16 (N. PT.) & LOT 17 (N. PT.), TOWN PLAT OF NORTH DEFIANCE (a.k.a. NORTH DEFIANCE ADDITION), DEFIANCE COUNTY, OHIO
