DEFIANCE—It is my privilege to present the Annual Report for the Office of the Defiance County Engineer for the year 2015.

Our Highway Garage Staff replaced two county bridges and also did much of the support work for the roadside grading and widening work. There were a total of eleven culverts replaced this year. They continued with their various other duties as well (replacing berm, mowing, patching, sign replacement, roadside tree trimming and removal, snow & ice control/removal, etc.).

Harris Rd between Blanchard Road and SR 18 was widened and paved by Gerken Paving. The project began in August and was finished in September. The pavement was widened from 20' width to 24' width. Right of Way and grading had been done in previous years. The cost of this project was \$1,219,744.84 with funding from FHWA and OPWC.

This year there were several ditches regraded along Banner School Rd from Evansport Rd to SR 66. Other ditches that were regraded are: Krouse Rd, Stever Rd, Powers Rd and Buckskin Rd.

Our administrative staff manages the overall office functions and budget of the Engineer's Office. They also help with the designing, engineering and overseeing of all aspects of the construction projects. With their diligence, we were able to obtain \$1,108,614.21 in federal and state grants for this year's projects as well.

I want to take this opportunity to thank the residents of Defiance County for the opportunity to serve you.

1,582.84 tons of asphalt were used to patch and repair township roadways in the following townships: Adams, Defiance, Hicksville, High-· land, Mark, Milford, Noble, Tiffin, Richland, and Washington. The cost to the townships was \$206,270.68.

2015 CRACK SEALING

42,438 pounds of crack sealing material were applied to 21.57 miles of county roadways at a cost of \$43,923.33.

21.15 miles of township roadways were sealed using 46,594 pounds of crack sealing material under the supervision of the County Engineer's Office. The cost for township crack sealing was \$48,224.80.

2015 CHIP SEALING

4,942 tons of stone and 125,634 gallons of e liquid asphalt were applied to 36.86 miles of county roadways during this year's chip sealing program. This year's cost was \$380,154.03.

72.36 miles of township roads were chip sealed using 9,544 tons of stone and 256,913 gallons of liquid asphalt at a cost of \$737,887.78. All the townships participated this year except one.

2015 PAVEMENT MARKING PROGRAM
