DEFIANCE—It is my privilege to present the Annual Report for the Office of the Defiance County Engineer for the year 2017.

Our Highway Garage Staff replaced three county bridges and also did much of the support work for the roadside grading and widening work. There were a total of twenty-three culverts replaced this year. They continued with their various other duties as well (replacing berm, mowing, patching, sign replacement, roadside tree trimming and removal, snow & ice control/removal, etc.).

This year we paved and widened several roads through out the County. Some of these roads include: Blosser between SR 2 and Openlander Rd, New BavariaRd between SR 18 and the Defiance Henry County Line Rd, Moser Rd between Mekus and Allen Rd, Defiance Ayersville Pleasant Bend Rd from 1535' West of Highland Center Rd to Steinmeier Rd, Ney Williams Center Rd between SR 249 and US 127, Mansfield Rd between SR 15 and Harris Rd, Elliott Rd between SR 66 and Carpenter Rd and Carter between SR 66 and SR 15.

The paving was done by Gerken Paving and the widening was done by RG Zachrich Construction. The total project cost was \$1,287,098.07.

Our administrative staff manages the overall office functions and budget of the Engineer's Office. They also help with the designing, engineering and overseeing of all aspects of the construction projects. With their diligence, we were able to obtain \$534,840.00 in federal

and state grants for this year's projects as well.

I want to take this opportunity to thank the residents of Defiance County for the opportunity to serve you.

## 2017 CRACK SEALING

**100,457** pounds of crack sealing material were applied to 45.5 miles of county roadways at a cost of \$105,479.85.

22 miles of township roadways were sealed using 41,296 pounds of crack sealing material under the supervision of the County Engineer's Office. The cost for township crack sealing was \$43,360.80

#### 2017 CHIP SEALING

**2,135** tons of stone and **56,589** gallons of • liquid asphalt were applied to 16.37 miles of county roadways during this year's chip sealing program. This year's cost was \$150,603.80.

• 58.25 miles of township roads were chip sealed using 7,265 tons of stone and 193,394 gallons of liquid asphalt at a cost of \$538,689.79. All the townships participated this year except one.
