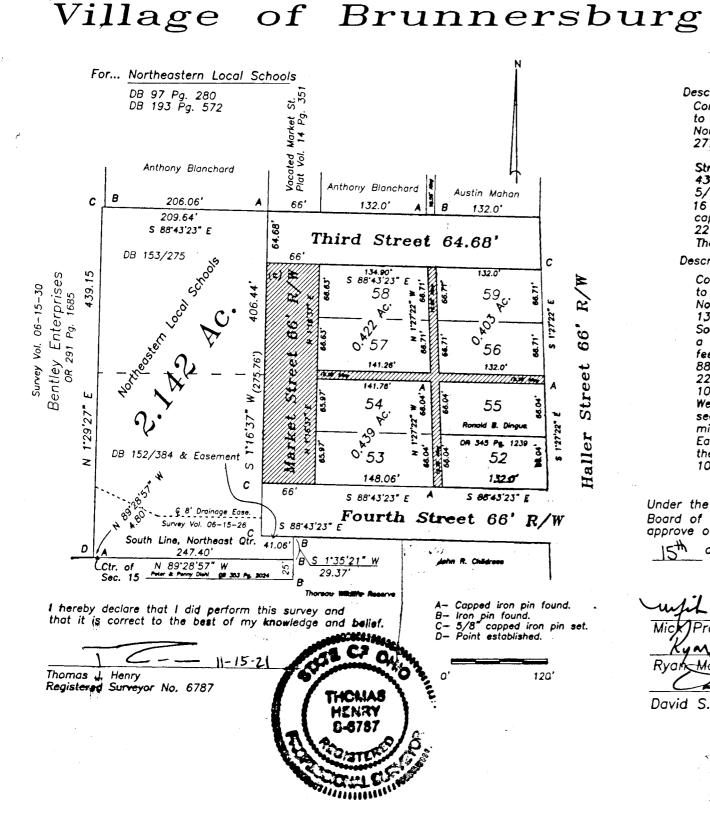
Vacation Plat of a portion of Market Street and alleys to the

Description of Vacated portion of Market Street: 0.417 Acres

Commencing at the Northeast corner of Lot No. 59 of Bruner & Zellers Second Addition to the Village of Brunnersburg monumented by a 5/8-inch capped iron pin set; thence North 88 degrees 43 minutes 23 seconds West, on the south line of Third Street, 277.55 feet to the east line of Market Street, and the point of beginning;

Thence South 01 degrees 16 minutes 37 seconds West, on the east line of Market Street, 275.76 feet to the Southwest corner of Lot No. 53; thence North 88 degrees 43 minutes 23 seconds West, on the north line of the Fourth Street, 66.00 feet to a 5/8-inch capped iron pin set on the west line of Market Street; thence North 01 degrees 16 minutes 37 seconds East, on the west line of Market Street, 275.76 feet to a 5/8-inch capped iron pin set on the south line of Third Street; thence South 88 degrees 43 minutes 22 seconds East, on the south line of Third Street 66.00 feet to the point of beginning.
