

Lot 45A – 0.238 Acres

Thence, South 34 degrees 58 minutes 00 seconds East along the East line of said Lot 45, a distance of 100.10 feet;

Thence, South 57 degrees 53 minutes 12 seconds West a distance of 106.43 feet to the West line of said Lot 45;

Thence, North 34 degrees 58 minutes 00 seconds West along the West line of said Lot 45, a distance of 94.80 feet to south right-of-way of Heatherdowns Drive;

Thence, North 55 degrees 02 minutes 00 seconds East along the south right-of-way of Heatherdowns Drive, a distance of 106.30 feet to the TRUE POINT OF BEGINNING;

Thence, South 34 degrees 58 minutes 00 seconds East along the East line of said Lot 45, a distance of 100.10 feet to the TRUE POINT OF BEGINNING;

Thence, continuing South 34 degrees 58 minutes 00 seconds East along the East line of said Lot 45, a distance of 103.16 feet to the Southeast corner of Lot 45, said point being marked with an iron pin, found this survey;

Thence, South 51 degrees 51 minutes 14 seconds West along the South line of said Lot 45, a distance of 106.46 feet to the Southwest corner of said Lot 45, said point being marked with an iron pin, found this survey;

Thence, North 34 degrees 58 minutes 00 seconds West along the West line of said Lot 45, a distance of 114.34 feet;

Thence, North 57 degrees 53 minutes 12 seconds East a distance of 106.43 feet to the TRUE POINT OF BEGINNING;
