## PARCEL 1 - 0.559 ACRES

Situated as part of Lot 45 and part of Lot 46 in the Westwood Addition to the City of Defiance, Township 4 North, Range 4 East, Defiance County, Ohio, as recorded in Survey Volume W-004-000, also being part of tracts of land as recorded in Official Record Volume 58, Page 275 and Official Record Volume 307, Page 1550 and more particularly described as follows:

Beginning at a 3/4 inch iron pipe found on the Southern right-of-way of Westwood Drive marking the Northeastern corner of said Lot 45 and the POINT OF BEGINNING;

Thence South 26°11'01" East along the Eastern line of said Lot 45 and extended a distance of 238.04 feet to a 5/8 inch rebar with ID cap set, passing a 5/8 inch rebar with ID cap set at 200.00 feet marking the Southwest corner of Lot 44 in Westwood Addition;

Thence North 89°41'03" West along a new division a distance of 174.79 feet to a 5/8 inch rebar with ID cap set on the East right-of-way of Westwood Drive and the West line of said Lot 45;

Thence North 02°02'18" East along said East right-of-way and said West line a distance of 184.73 feet to a point marking the Northwest corner of said Lot 45, referenced by a 3/4 inch iron pipe found lying 0.563 feet North and 0.14 feet West of said point;

Thence North 66°04'22" East along the Southern right-of-way of Westwood Drive and the North line of said Lot 45 a distance of 69.12 feet to the POINT OF BEGINNING, said tract containing 0.559 acres of land, more or less.



Situated as part of Lot 45 and part of Lot 46 in the Westwood Addition to the City of Defiance, Township 4 North, Range 4 East, Defiance County, Ohio, as recorded in Survey Volume W-004-000, also being part of tracts of land as recorded in Official Record Volume 58, Page 275 and Official Record Volume 307, Page 1550 and more particularly described as follows:

Commencing at a 3/4 inch iron pipe found on the Southern right-of-way of Westwood Drive marking the Northeastern corner of said Lot 45;

Thence South 26°11'01" East along the Eastern line of said Lot 45 a distance of 200.16 feet to a 5/8 inch rebar with ID cap set marking the Southeast corner of said Lot 45 and the POINT OF BEGINNING:

Thence North 66°04'22" East along the North line of said Lot 46 a distance of 119.23 feet to a 5/8 inch rebar with ID cap set on the South line of Lot 43 in said Westwood Addition marking the Northeast corner of Tract 1 as recorded in said Official Record Volume 307, Page 1550;

Thence South 02°02'18" West along the East line of said Tract 1 a distance of 211.31 feet to a 5/8 inch rebar with ID cap set marking the Southeast corner of said Tract 1;

Thence North 87°57'42" West along the South line of said Tract 1 a distance of 263.99 feet to a point found on the East right-of-way of Westwood Drive marking the Southwest corner of said Tract 1, referenced by an iron pin found lying 0.66 feet East of said point;

Thence North 02°02'18" East along said East right-of-way and a distance of 120.48 feet to a 5/8 inch rebar with ID cap set;

Thence South 89°41'03" East along a new division a distance of 174.79 feet to a 5/8 inch rebar with ID cap set;

Thence North 26°11'01" West along a new division a distance of 37.88 feet to the POINT OF BEGINNING, said tract containing 0.891 acres of land, more or less.
