LEGAL DESCRIPTION

A parcel of land being part of the Southeast Quarter of Section 8, Township 4 North, Range 4 East, Noble Township, Defiance County, Ohio and being more particularly described as follows:

Commencing at an iron pin at the Northeast corner of the Southeast Quarter of Section 8;

THENCE South 89 degrees 45 minutes 15 seconds West, on the North line of the Southeast Quarter of Section 8, for a distance of 1282.74 feet, to a 5/8" X 30" iron pin and reference cap set;

THENCE South 35 degrees 39 minutes 01 seconds West, for a distance of 51.33 feet, to a 5/8" X 30" iron pin and reference cap set;

THENCE South 00 degrees 10 minutes 01 seconds West, for a distance of 597.82 feet, to a 5/8" X 30" iron pin and reference cap set, being the **TRUE POINT OF BEGINNING** for the parcel herein described; THENCE continuing South 00 degrees 10 minutes 01 seconds West, for a distance of 321.70 feet, to a 5/8" X 30" iron pin and reference cap set:

THENCE South 89 degrees 40 minutes 40 seconds West, for a distance of 24.39 feet, to a 5/8" X 30" iron pin and reference cap set, being on the East line of the West half of the Southeast Quarter of Section 8; THENCE continuing South 89 degrees 40 minutes 40 seconds West, for a distance of 671.80 feet, to a 5/8" X 30" iron pin and reference cap set;

THENCE North 00 degrees 10 minutes 19 seconds West, for a distance of 321.69 feet, to a 5/8" X 30" iron pin and reference cap set;
