Thence, South 0 degrees 55 minutes 40 seconds West along the East line of the West Half of the Northwest Quarter of said Section 21 a distance of 1890.99 feet to an iron pin found this survey;

Thence, North 89 degrees 02 minutes 12 seconds West along the South line of the Northwest Quarter of said Section 21 a distance of 747.50 feet to a point established this survey;
